

BLACK FRIDAY EL TRIANGLE

Legal Bases

FIRST. - ORGANIZING ENTITY

The Association of Merchants of the El Triangle Shopping Center (hereinafter, "El Triangle") with CIF number V61851234 and with its registered office at Plaza Cataluña, nº 1, 08002 Barcelona, organizes, on the dates indicated below, an event aimed at the users of the El Triangle Shopping Center in accordance with the instructions detailed in these terms and conditions.

SECOND. – EVENT TERMS

I.- Personal scope:

All individuals who meet the established participation requirements in these legal terms may participate in this action.

II.- Time limit:
