Legal Bases

FIRST. - ORGANIZING ENTITY

The Association of Merchants of the El Triangle Shopping Center (hereinafter, "El Triangle") with CIF number V61851234 and with its registered office at Plaza Catalunya, nº 1, 08002 Barcelona, organizes, on the dates indicated below, an event aimed at the users of the El Triangle Shopping Center in accordance with the instructions detailed in these terms and conditions.

SECOND. – EVENT TERMS

I.- Personal scope:

All individuals who meet the established participation requirements in these legal terms may participate in this action.

II.- Time limit:

The action will take place between October 5 and October 12, 2024, from 4:00 PM to 8:00 PM each day, ending on October 12 at 8:00 PM or while supplies last.

III.- Access to the event and participation:

To participate in the event, which will take place under the conditions established in these terms, participants must show the hostesses located in the center a purchase receipt from any store located in the El Triangle Shopping Center (no minimum amount required), complete a form via a QR code provided by the hostesses, and submit the final coupon to the Amorino store located in the same El Triangle Shopping Center, and meet the requirements defined in Clause Three of these legal terms.

THIRD. - PARTICIPATION MECHANICS

To participate in the event, which will take place under the conditions established in these terms, participants must show the hosts located in the center a purchase receipt (no minimum amount required) from any store located in the El Triangle Shopping Center, which the hostesses will stamp. Participants must fill out the form available on the El Triangle website, accessed via the QR code provided by the hostesses. Once completed, one coupon per person per day will be given (while supplies last or until Saturday, October 12, 2024, at 8:00 PM), which can be redeemed for an ice cream of the size determined by the organization, with a flavour of their choice at the Amorino store located in the El Triangle Shopping Center.

All participants who complete all the steps of the participation mechanics described in Clause Three of these legal terms are eligible to participate in the Festes del Roser El Triangle x Amorino action, organized by the El Triangle Shopping Center and Amorino.
