

# **EL TRIANGLE SUMMER WHEEL ACTION**

## Legal Terms and Conditions

### **FIRST. - ORGANIZING ENTITY**

The Association of Merchants of the El Triangle Shopping Center (hereinafter referred to as "El Triangle") with CIF number V61851234 and registered office at Plaza Cataluña, No. 1, 08002 Barcelona, organizes, on the dates indicated below, a raffle aimed at users of El Triangle Shopping Center's Instagram digital platform in accordance with the instructions detailed in these terms and conditions.

### **SECOND. - RAFFLE RULES**

I. - Personal Scope: All individuals who meet the participation requirements set out in these legal bases may participate in this action.

II. - Temporal Scope: The action will take place every weekday afternoon between July 15 and August 16, 2024, on the following days: July 15, 16, 17, 18, 19, 22, 23, 24, 25, 26, 29, 30, and 31, and August 1, 2, 5, 6, 7, 8, 9, 12, 13, 14, 15, and 16, from 4:00 PM to 8:00 PM on all the aforementioned days (hereinafter, the "Period"). The action will end on Friday, August 16 at 8:00 PM.

III. - Access to the Raffle and Participation: To participate in the raffle, which will be carried out under the conditions established in these terms and conditions, participants must show a purchase receipt from any establishment within El Triangle Shopping Center. Additionally, they must register in the 'Summer Time' campaign form provided by the hostesses and meet the requirements defined in Clause Three of these legal terms and conditions.

### **THIRD. - PARTICIPATION MECHANICS**

To participate in the contest, which will be conducted under the conditions established in these rules, participants must show a receipt from any establishment within El Triangle Shopping Center and fill in their personal details on the "Summer Time" campaign form by accessing it via the QR code. Once the receipt is stamped and the registration is complete, and only when both conditions are met, the participant will be allowed one spin of the Summer Time Wheel, with a subsequent prize. Each person can only participate with one receipt per day and can only spin the wheel once per day.

### **FOURTH. - ACTION MECHANICS**

All participants who comply with the participation mechanics described in Clause Three of these legal bases have the possibility to participate in one spin of the Summer Time Wheel and the possibility of winning a subsequent prize.

### **FIFTH. - WINNER ANNOUNCEMENT AND PRIZE DELIVERY**

At the moment of spinning the Summer Time Wheel, the participant will receive the prize they win, if any.

### **SIXTH. - PRIZES**
