

OSCARS EL TRIANGLE

Legal Bases

FIRST. - ORGANIZING ENTITY

The Association of Merchants of the El Triangle Shopping Center (hereinafter, "El Triangle") with CIF number V61851234 and with its registered office at Plaza Cataluña, nº 1, 08002 Barcelona, organizes, on the dates indicated below, an event aimed at the users of the El Triangle Shopping Center in accordance with the instructions detailed in these terms and conditions.

SECOND. – EVENT TERMS

I.- Personal scope:

All individuals who meet the established participation requirements in these legal terms may participate in this action.

II.- Time limit:

The campaign will take place from February 24 to March 2, 2025, with the latter being the last day to participate. The final draw will be held on March 3, 2025 (hereinafter, the "Deadline"). El Triangle will contact the winner on March 3, 2025, via email and/or direct message on Instagram.

III.- Access to the event and participation:

To participate in the giveaway, which will be held under the conditions set out in these rules, participants must fill out the form available on the website, created specifically for the Oscars campaign.

THIRD. - PARTICIPATION MECHANICS

To participate in the giveaway, which will be conducted under the conditions set forth in these rules, participants must complete the form available on the website, specifically created for the Oscars campaign.

FOURTH. - ACTION MECHANICS

All participants who complete all the steps of the participation process described in Clause Three of these legal terms have the possibility to enter the giveaway.

FIFTH. - WINNER ANNOUNCEMENT AND PRIZE DELIVERY

On March 3, 2025, the name of the winner will be announced via Instagram Stories. The winners will have a period of two (2) calendar days to respond to the message and provide the necessary information to manage the collection of the prize.

If they do not respond, the winners will not be able to claim the Prize from El Triangle, and El Triangle may decide to (i) keep the Prize and/or (ii) have the Management of the El Triangle Shopping Center choose another winner from those participants who have complied with these legal terms and name a new winner.

The Management of the El Triangle Shopping Center will hand over the prize in person at the reception of the El Triangle Shopping Center.

SIXTH. - PRIZES

The period to claim any problem or eventuality related to this action will end one (1) week after the conclusion of the term.

EIGHTH. - ACCEPTANCE OF TERMS

By merely participating in this event, participants accept these terms and the criteria of El Triangle regarding the resolution of any matter arising from the development of this event. El Triangle may, if it detects any fraudulent use of the promotion, modify these terms in any provisions deemed necessary to ensure the proper functioning of the event.
